#### Parent/Guardian Consent

#### Assumption of Risk

I acknowledge that participation in church-sponsored programs involves inherent risks, including but not limited to travel by automobile, van, bus, ferry, or other transportation; physical activity and outdoor conditions; use of tools or equipment; water-based activities; and wilderness terrain or remote settings. These risks may result in injury, illness, property damage, permanent disability, or death.

I voluntarily assume all risks associated with my child's participation, whether known or unknown, inherent or arising from the ordinary negligence of others, except for gross negligence or willful misconduct.

#### Program-Specific Risk Acknowledgment

##### *If Participating in Appalachia Service Project:*

I understand that the program may involve light construction activities including use of hand tools, power tools, ladders, and work on residential properties. Risks may include cuts, falls, strains, and other construction-related hazards.

##### *If Participating in Beyond Malibu:*

I understand that this program involves international travel to British Columbia, Canada, and wilderness hiking activities including mountain terrain, elevation changes, carrying loaded backpacks, variable weather conditions, and limited access to immediate medical facilities.

I acknowledge that participants also complete required Young Life/Beyond Malibu health and release forms, including physician clearance and jurisdiction agreements.

***If Participating in Splash Camp:***

I understand that this program includes swimming and water-based activities at Hopewell Quarry, a third-party facility. Risks may include drowning, slipping, falling, exposure to cold water, and other aquatic hazards.

I acknowledge that participants must comply with Hopewell Quarry's rules and waiver requirements.

**Release and Hold Harmless**

To the fullest extent permitted by law, I release and hold harmless Nassau Presbyterian Church, its trustees, officers, directors, employees, clergy, volunteers, and agents from any and all claims, demands, damages, causes of action, or liability arising out of or related to my child's participation, including claims arising from ordinary negligence.

**Insurance Responsibility (Appalachia Service Project and Splash Camp)**

I understand that my child's personal medical insurance is primary for any illness or injury. Nassau Presbyterian Church does not provide health or medical insurance coverage for participants in these programs, and I am financially responsible for any medical expenses incurred.

**Insurance Responsibility (Beyond Malibu – Canada Only)**

Nassau Presbyterian Church has purchased supplemental travel medical and emergency evacuation insurance for participants in the Beyond Malibu trip. This coverage is limited and is intended to supplement, not replace, personal health insurance. I understand that I remain financially responsible for any medical expenses not covered by my personal insurance and/or the supplemental travel policy.

**Medical Authorization**

In the event of injury or illness, I authorize Nassau leaders to seek appropriate medical treatment for my child. Reasonable efforts will be made to contact me prior to treatment.

**Transportation Authorization**

I give permission for my child to be transported by Nassau staff or approved volunteers in privately owned or rented vehicles, or by commercial carriers, as part of program activities.

**Behavioral Expectations**

I understand that participation is a privilege and that Nassau reserves the right to send my child home at my expense if behavior jeopardizes safety or significantly disrupts the program.

**Media Release**

I grant permission for Nassau Presbyterian Church to use photographs or video recordings of my child for church publications, website, or social media.
